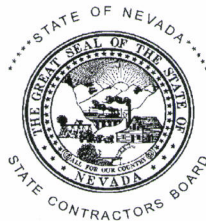


ALJ Georgeson found Respondent Ralph Richard Pane, Owner, dba Thermal Services guilty of one (1) violation of NRS 624.3014(2)(a), (c), (d) aiding or abetting, allowing a license to be used, and acting as agent, partner or associate of an unlicensed person; one (1) violation of NRS 624.3013(5), as set forth in NAC 624.640(5) failure to include its license number and monetary license limit on its contracts; and one (1) violation of NRS 624.3011(1)(b)(4) violation of the laws of

this State regarding industrial insurance. The Fourth and Fifth Causes of Action were dismissed. Respondent Ralph Richard Pane, Owner, dba Thermal Services was assessed a fine of \$500.00 for the First Cause of Action; a fine of \$100.00 for the Second Cause of Action; a fine of \$1,000.00 for the Third Cause of Action for total fines of \$1,600.00 and investigative costs of \$2,246.00. Upon receipt of payment of fines and investigative costs, the Board will accept the voluntary surrender of license number 56799, Ralph Richard Pane, Owner, dba Thermal Services. Failure to timely pay the fines and investigative costs shall result in the revocation of license number 56799, Ralph Richard Pane, Owner, dba Thermal Services.


There being no further business to come before the Board, the meeting was adjourned by ALJ Georgeson at 8:41 a.m.
