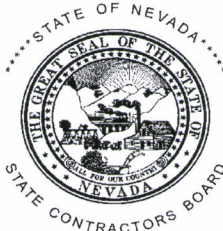

**SIERRA NEVADA ENTERPRISES, dba STATESIDE NEVADA EARTHWORKS,** License No. 81726


Licensee was not present nor represented by counsel at the hearing.

**ADJOURNMENT**


There being no further business to come before the Board, the meeting was adjourned by ALJ Georgeson at 10:09 a.m.
