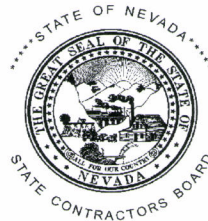



ADJOURNMENT


There being no further business to come before the Board, the meeting was adjourned by ALJ Allison at 11:59 a.m.
