

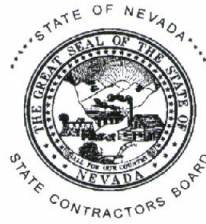

ADJOURNMENT


There being no further business to come before the Board, the meeting was adjourned by ALJ Allison at 10:50 a.m.
