## 14 NEVADA CONTRACTORS DISCIPLINED BY CONTRACTORS BOARD

(Henderson, NV) – At its meetings on May 27 and 28, 2009, the Nevada State Contractors Board adjudicated cases involving 14 contractors.

---

***Helix Construction***, license number 49901 (Residential & Small Commercial); ***Helix Construction, dba Helix Concrete***, license number 68267 (Concrete Contracting); ***Helix Construction, dba Urban Framers***, license 60255 and 67858 (Carpentry and Painting & Decorating) based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for failure to establish financial responsibility; failure to keep in force a bond or cash deposit; and for the partnership, corporation, firm or association participating in a prohibited act. The licensee was fined \$1,000 and ordered to pay investigative costs and ordered to make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. The licenses were revoked.

***Comfort Express, LLC.***, license number 67994 (Air Conditioning) based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for failure to respond to a written request from the Board; contracting on a suspended or revoked license; failure to keep in force a bond or cash deposit; and failure to establish financial responsibility. The licensee was fined \$2,000 and ordered to pay investigative costs and ordered to make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. The license was revoked.

***R & T Martin, Inc.***, license numbers 57332 and 56446 (Refrigeration & Air Conditioning and Electrical Contracting) based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for failure to establish financial responsibility and for the partnership, corporation, firm or association participating in a prohibited act. The licensee was fined \$500 and ordered to pay investigative costs and ordered to make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. The licenses were revoked.

**McDougal Concrete Sawing and Drilling, Inc.**, license number 43209 (Concrete Contracting), based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for failure to respond to a written request from the Board and failure to establish financial responsibility. The licensee was fined \$1,000 and ordered to pay investigative costs and ordered to make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. The license was revoked.

**Sabr Construction, LLC.**, license numbers 67976 and 68818 (Excavating Grading Trenching & Surfacing and Electrical) based out of Henderson, NV, has had its licenses summarily suspended.

**Aesthetic Concrete, Inc.**, license number 46701A (Concrete Contracting), based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for failure to establish financial responsibility. The licensee was fined \$500; ordered to pay investigative costs and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. The license was revoked.

**Thomas Ivan Richardson, dba Richardson Coatings & Tile**, license number 59565 (Concrete Contracting and Concrete Overlays & Coatings), based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for failure to respond to a written request from the Board; failure to keep in force a bond or cash deposit; and failure to establish financial responsibility. The licensee was fined \$1,500; ordered to pay investigative costs and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. The license was revoked.

**Bobby Wayne Lang, dba Omega Air Conditioning**, license number 14580 (Refrigeration & Air Conditioning) based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for failure to respond to a written request from the Board and failure to establish financial responsibility. The licensee was fined \$1,000; ordered to pay investigative costs and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. The license was revoked.

**P.S.C.O., Inc.**, license number 57509 (Electrical Signs) based out of Henderson, NV, was found in violation of Nevada Revised Statute 624 for failure to comply with a written citation and failure to keep in force a bond or cash deposit. The licensee was fined \$1,000; ordered to pay investigative costs and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. The license was revoked.

**R&J Electric, LLC., dba R&J Electric, LLC.**, license number 59545 (Residential Wiring); **R&J Electric, LLC., dba R&J Construction**, license number 70935 (Residential & Small Commercial); **R&J Electric, dba Bulls Eye Concrete**, license number 70991 (Concrete Contracting) based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for willful disregard of the building laws of the state; failure to establish financial responsibility; and for the partnership, corporation, firm or association participating in a prohibited act. The licensee was fined \$1,500; ordered to pay investigative costs and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. The licenses were revoked.

***Take It For Granite Too***, license numbers 52235, 52236 and 66293 (Residential & Small Commercial, Install Terazzo & Marble and Tiling), based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for failure to respond to a written request from the Board; failure to establish financial responsibility; and for the partnership, corporation, firm or association participating in a prohibited act. The licensee was fined \$1,000; ordered to pay investigative costs and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. The licenses were revoked.

***Robertson Tile, Marble & Granite, Inc.***, license number 47345 (Tiling), based out of Blue Diamond, NV, was found in violation of Nevada Revised Statute 624 for failure to comply with a written citation. The licensee was fined \$1,000; ordered to pay investigative costs and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. The license was revoked.

---

***William Joseph Saddler, dba Bills Painting***, license number 68541 (Painting ), based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for substandard workmanship; failure to take appropriate corrective action; failure to notify the Board of a change in personnel or address within 30 days of the change; failure to include the monetary license limit and license number on a contract or proposal; failure to include the Residential Recovery Fund information on a contract or proposal and failure to establish financial responsibility. The licensee was fined \$3,000; ordered to pay investigative costs and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. The license was revoked.

---

***Construction Systems***, license number 57077 (Residential & Small Commercial), based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for failure to discharge a lien; failure to pay money due for materials and services; and failure to establish financial responsibility. The licensee was ordered to pay investigative costs, pay \$14,471.25 in restitution and provide a current compiled financial statement with full disclosures. The license was suspended.

**\*\*The Business Review Program is one in which a contractor's business practices and regulatory compliance is examined by NSCB investigative staff. The program is a part of NSCB's proactive investigative efforts.**

***The Nevada State Contractors Board is committed to protecting the public's health, safety, and welfare through licensing and regulation of the construction industry. Under Nevada Revised Statutes, a licensee is subject to disciplinary action by the Board for failure to comply with the requirements of the laws or regulations governing contractors. Violations may result in Board action against the contractor's license. The State Contractors Board has the power to regulate contractors and discipline licensees who violate NRS 624. Disciplinary action may consist of a fine of up to \$10,000 per offense, order corrective action, suspension, revocation or other action.***
