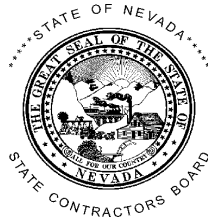

**2. DISCIPLINARY HEARING:**

**U. S. MECHANICAL, LLC, LICENSE NO. 31212A**

Licensee was present with counsel, Gregory Gilbert.

Hearing Officer Cavin found the respondent U. S. Mechanical, LLC, Brad Kenneth Bylund, Member, license number 31212A guilty of the first, second and third causes of action and dismissed the fourth cause of action. Mr. Bylund is issued license number 54123, C-21 (Refrigeration and Air Conditioning) effective April 1, 2004. License numbers 31212A and 54123 are suspended for 120 days. The suspension is stayed on the condition that Mr. Bylund shall not bid or perform work, directly or indirectly, on the Meadows Hospital project for a period of 120 days. Mr. Bylund was assessed a fine of \$3,000.00 per cause of action totaling \$9,000.00. Investigative costs were assessed in the amount of \$4,393.00. If fines and costs are not paid within 90 days from April 1, 2004, license numbers 31212A and 54123, U. S. Mechanical, LLC will automatically be Revoked.
