**1. DISCIPLINARY HEARING: DEFAULT HEARING  
D N ROOFING INC, LICENSE NO. 57056**

Licensee was not present.

Hearing Officer Robb found the Respondent D N Roofing, license number 57056 guilty of violating NRS 624.3017(1) substandard workmanship; NRS 624.3013(5), as set forth in NRS 624.700(3)(a) failure to comply with the Board's Notice to Correct; NRS 624.3013(5), as set forth in NRS 624.520(1) failure to provide Residential Recovery Fund Notice to owner and NRS 624.3013(3) failure to establish financial responsibility. License number 57056 is revoked. Respondent shall pay a fine of \$500.00 for the First Cause of Action, \$500.00 for the Second Cause of Action, \$100.00 for the Third Cause of Action and \$500.00 for the Fourth Cause of Action for a total fine of \$1,600.00; reimburse the Board Investigative fees of \$1,836.00 and restitution be ordered to the homeowner.

**2. DISCIPLINARY HEARING: DEFAULT HEARING  
ADVANCED GREEN BUILDERS INC, LICENSE NOS. 69549, 76325 and 77731**

Hearing Officer Robb allowed Mr. Jiminez to withdraw as the Qualified Individual and revoked license numbers 69549, 76325 and 77731. The decision on the fines and fees will be held in abeyance and continued this matter to the May 7, 2014 hearing.

**3. DISCIPLINARY HEARING:**  
**IMTIAZ AHMED DBA, LOBO ROOFING, LICENSE NO. 70178**

Licensee was present.

Hearing Officer Robb found the Respondent Imtiaz Ahmed dba, Lobo Roofing, license number 70178 guilty of violating NRS 624.3011(1)(b)(2) failure to comply with the safety laws or labor laws of the state; NRS 624.3013(5), as set forth in NRS 624.520(1) failure to provide Residential Recovery Fund Notice to owner and NRS 624.3013(5), as set forth in NAC 624.640(5) each licensee shall include in all bids he submits or contracts he enters into for construction work within this State, the number of his license and any monetary limit placed upon his license. Imtiaz Ahmed dba, Lobo Roofing shall pay an administrative fine of \$500.00 for the First Cause of Action, \$100.00 for the Second Cause of Action and \$100.00 for the Third Cause of Action for a total fine in the amount of \$700.00 and reimburse the Board investigative fees of \$1,773.00. Fines and fees shall be paid within ninety (90) days from the March 5, 2014 hearing or license number 70178 will automatically be suspended.

**4. FINANCIAL RESPONSIBILITY HEARING: CONTINUED FROM JANUARY 8, 2014**  
**TMB BUILDERS LLC, LICENSE NO. 39502**

Licensee was present.

Hearing Officer Robb ordered licensee must provide a letter to proposed clients informing them that TMB Builders, LLC is in bankruptcy and cannot start work until the Board receives a financial statement supporting the license limit. This matter was continued to April 2, 2014.

**5. FINANCIAL RESPONSIBILITY HEARING:**  
**BRIGADOON COMMUNICATION INC., LICENSE NO. 76931**

Licensee was not present.

Hearing Officer Robb found Respondent guilty of violating NRS 624.3013(3) failure to establish financial responsibility; NRS 624.302(5) failure to comply with written request of the Board and NRS 624.3013(4) failure to keep in full force the bond or cash deposit pursuant to NRS 624.270 for the full period required by the Board. Respondent must pay a fine of \$1,500.00 and investigative fees in the amount of \$467.00. License number 76931 is revoked.

**6. FINANCIAL RESPONSIBILITY HEARING:**  
**TECH PLUMBING & HEATING INC. LICENSE NO. 77233**

Licensee was present.

Hearing Officer Robb dismissed the First Cause of Action NRS 624.3013(3) failure to provide financial responsibility and ordered Respondent to pay the investigative fee in the amount of \$496.64 within ten (10) days.

**7. FINANCIAL RESPONSIBILITY HEARING:**  
**EC AC HEATING AND AIR CONDITIONING SERVICE LLC. LICENSE NO. 76400**

Licensee was present.

Hearing Officer Robb found Respondent guilty of violating NRS 624.3013(3) failure to establish financial responsibility. No fine was assessed. Respondent must pay investigative fees in the amount of \$490.30 within sixty (60) days or license will automatically be suspended. Respondent shall update the Secretary of State within thirty (30) days or license will automatically be suspended.

There being no further business to come before the Board, the meeting was adjourned by Adjudicating Law Judge Robb at 9:56 a.m.
