Lastly, Ms. Grein noted the Residential Recovery Fund meeting had been rescheduled to January 22, 2018.

#### 6. EXECUTIVE SESSION

Executive Officer's Report

Ms. Grein provided an update on the Governor's Office of Finance Audit, the Legislative Commission's Sunset Review Subcommittee's Audit for both the Board and the Commission on Construction Education, and the leadership and staff training program, which will last from January to October, 2018. Ms. Grein also noted that she will be attending the FARB (Federal Association of Regulatory Boards) conference from January 25-28, 2018.

Review of Monthly Department Statistics

Ms. Grein provided the following statistics for the month of November and December, noting that a recent database conversion has temporarily limited the data that can be reported on for this month:

- Licensing Division:
  - Received 257 new license applications and 369 change applications;
  - Issued 158 new licenses:
  - Approved 99 Financial Reviews; and
  - Processed 870 inactive and active license renewal applications
- Compliance Division:
  - Issued 21 Administrative Citations;
  - Held 18 Disciplinary Hearings; and
  - Opened 3 Recovery Fund claims.
- Criminal Division:
  - Opened 104 complaints; and
  - Issued 51 court filings, 48 misdemeanor charges, 4 gross misdemeanor charges and 4 felony charges for the alleged suspects.

- Additional Board Activities:
  - During November and December, Ms. Grein attended a Board and Commission training provided by the Attorney General's Office, gave a presentation to the Commercial Real Estate Women (CREW) Las Vegas Chapter, and attended the first Occupational Licensing Learning Consortium meeting.
  - The Board held a Regulation Workshop and Hearing to receive comment on the proposed regulation to conform to the license by endorsement provisions provided in Senate Bill 69, which was adopted by the Board at the November meeting.
  - The Board held a Commission on Construction Education meeting where members awarded just over \$76,000 in grant funding, and a Residential Recovery Fund Committee meeting, which awarded just under \$54,000 to damaged homeowners.
  - The Board's public information office and enforcement department gave a presentation to the City of Henderson contracts personnel regarding Board resources, and participated in a Fire House Disaster Preparedness event with a number of state and local agencies.
  - The Board celebrated its veteran employees and members at its annual Veteran's Day luncheon and recognized staff for their years of service at its annual holiday luncheon.
- Discussion of NRS 232B.210 Concerning the Legislative Commission's Sunset Subcommittee Selection of Boards, Commissions, and Similar Entities for Sunset Review

Ms. Grein noted that the Board and the Commission on Construction Education were selected by the Legislative Commission's Sunset Subcommittee to be reviewed. Ms. Grein informed the Board that the Board will likely present to the Sunset Subcommittee at its February 21, 2018 meeting and that the information for the review is already being compiled and verified. Ms. Grein indicated she would keep the Board informed of any new information related to this matter.
