# DHD READY RENOVATION & CONSTRUCTION, LLC, License No. 77479

Licensee was present and represented by Adam Smith, Esq. at the hearing.

ALJ Allison found Respondent D H D Ready Renovation & Construction, LLC, license number 77479 in default and adopted the Findings of Fact and Conclusion of Law as set forth in the Administrative complaint. Respondent D H D Ready Renovation & Construction, LLC was found guilty of six (6) violations of NRS 624.3011(1)(b)(1) violation of the building laws of the State; nine (9) violations of NRS 624.3015(1) acting in the capacity of a contractor beyond the scope of the license; nine (9) violations of NRS 624.3013(5) as set forth in NAC 624.640(5) failure to include its license number and monetary license limits on its contracts; seven (7) violations of NRS 624.301(5) failure to comply with the terms of a construction contract; four (4) violations of NRS 624.3017(1) workmanship which is not commensurate with the standards of the trade in general; four (4) violations of NRS 624.3013(5), as set forth in NAC 624.700(3)(a) failure to comply with the Board's Notice to Correct; eight (8) violations of NRS 624.3013(5), as set forth in NRS 624.520(1) failure to provide the required notice of the Residential Recovery Fund; one (1) violation of NRS 624.302(6) failure to comply with a written request by the Board; four (4) violations of NRS 624.3013(5), as set forth in NRS 624.750(4)(b) diversion of money; two (2) violations of NRS 624.301(1) abandonment of any construction project undertaken by the licensee as a contractor; one (1) violation of NRS 624.301(2) abandonment of a construction project when the percentage of the project completed is less than the percentage of the total price of the contract paid to the contractor; one (1) violation of NRS 624.305(1) unlawful use or transfer of license; one (1) violation of NRS 624.3013(5), as set forth in NAC 624.650(1) a licensee shall not permit his contracting business to be operated by an unlicensed or unqualified person; and one (1) violation of NRS 624.3013(3) failure to establish financial responsibility. The Second, Eleventh, Nineteenth and Twenty-Seventh Causes of Action were dismissed. Respondent D H D Ready Renovation & Construction, LLC was assessed a fine of \$1,000.00 for each of the First, Third, Fifth, Sixth, Eighth, Tenth, Fourteenth, Fifteenth, Sixteenth, Eighteenth, Twenty-First, Twenty-Second, Twenty-Fourth, Twenty-Sixth, Twenty-Ninth, Thirtieth, Thirty-Second, Thirty-Fourth, Thirty-Sixth, Thirty-Seventh, Thirty-Eighth, Fortieth, Forty-Second, Forty-Third, Forty-Fifth, Forty-Seventh, Forty-Ninth, Fiftieth, Fifty-First, Fifty-Third, Fifty-Fifth, Fifty-Sixth, Fifty-Seventh, and Fifty-Ninth Causes of Action; a fine of \$250.00 for each of the Fourth, Twelfth, Twentieth, Twenty-Eighth, Thirty-Fifth, Forty-First, Forty-Eighth, Fifty-Fourth, and Sixtieth Causes of Action; a fine of \$500.00 for each of the Seventh, Thirteenth, Twenty-Third, Thirty-First, Forty-Fourth, and Sixty-Third Causes of Action; a fine of \$100.00 for each of the Ninth, Seventeenth, Twenty-Fifth, Thirty-Third, Thirty-Ninth, Forty-Sixth, Fifty-Second, and Fifty-Eighth Causes of Action; a fine of \$5,000.00 for each of the Sixty-First and Sixty-Second Causes of Action for total fines of \$50,050.00 and investigative costs of \$6,599.00. License number 77479, D H D Ready Renovation & Construction, LLC was revoked. Respondent D H D Ready Renovation & Construction, LLC is required to make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund plus pay the fines and investigative costs prior to consideration of future licensure.
