1. CALL TO ORDER:

2. STATEMENT OF THE BOARD'S MISSION

Ms. Grein read the Board's mission statement into the record: "The Nevada State Contractors Board is committed to promoting public confidence and trust in the competence and integrity of licensees and to protect the health, safety, and welfare of the public."

Ms. Grein introduced Board Investigators, Chris Smith and Steven Edwards, and Administrative Assistant, Liliana Heidtman to the Board.

6. EXECUTIVE SESSION

Executive Officer's Report

Ms. Grein noted that the Commission on Construction Education met on May 13, 2019 to review and approve its Strategic Plan for 2019-2020.

Review of Monthly Department Statistics

Ms. Grein provided the following statistics for the month of April:

- Licensing Department:
 - Received 171 new license applications and 275 change applications;
 - · Issued 125 new licenses:
 - · Approved 46 Financial Reviews;
 - · Approved 581 inactive and active license renewal applications;
 - · Issued or renewed 31 Certificates of Eligibility;
 - Initiated 4 Actions Related to lapse in Workers' Compensation Insurance provided by the Department of Education, Training, and Rehabilitation;
 - · Held 5 new application denial hearings;
 - · Held 2 Business Assistance Programs with 41 participants.
- Investigations Department:
 - Opened a total of 207 complaints, including 129 compliance and 78 criminal complaints;
 - Held 13 Disciplinary Hearings, where 3 licenses were revoked.
 - A total of \$22,000 in fines and \$10,107 in investigative costs were assessed, and \$6,593 in restitution was ordered by the Board; and
 - 23 court filings were issued seeking prosecution for 17 misdemeanor charges, 4
 Gross Misdemeanor charges, and 6 felony charges against the alleged suspects.
- Other Activities:
 - Ms. Grein continued to work closely with our lobbyists, members of the Legislature, and interested parties on various legislative matters, including testifying before the Senate Commerce and Labor Committee on the Board's legislative package.

- Ms. Grein gave a presentation to the Nevada Association of Pool and Spa Professionals regarding the Board's efforts in the 2019 Legislative Session.
- Ms. Grein participated in two FARB Super Strategic Action Team planning meetings.
- Representatives from Morrissey Insurance provided all staff with an update on changes being made to the Board's insurance plans.
- Ms. Grein participated in a webinar put on by the Council of State Governments that focused on navigating the anti-regulatory environment and the responsibility and liability of Board members.
- Lastly, Board staff participated in a Buddy Bench event at Bailey Elementary School in Reno; attended a home show event at Sun City MacDonald Ranch; joined members of the industry for another construction workforce development panel at Canyon Springs High School, and conducted an interview with Channel 13 highlighting tips for homeowners purchasing a new home.

Discussion Concerning the Board's Disposition of Administrative Fines
