**BOARD TAKES DISCIPLINARY ACTION AGAINST FOUR CONTRACTORS**

(Henderson, NV) – At its meeting on March 25 and 26, 2003, the Nevada State Contractors Board adjudicated cases against four (4) licensed contractors.

---

***Westside Maintenance & Construction***, license number 46280 (Residential and Small Commercial) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for conviction of a crime involving moral turpitude. The Board placed the license of Westside Maintenance & Construction on a probationary status and licensee was assessed the cost of investigation.

***Jaehn Construction West***, license number 19223 (Residential and Small Commercial) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for failure to ascertain that each person considered for bid on a construction project is properly licensed; and bidding in excess of established license limit. A two-year letter of reprimand was placed in licensee's file; licensee was fined \$1,000 and assessed the cost of investigation.

***Panda Refrigeration***, license number 26472 (Refrigeration, Air Conditioning and Sheet Metal) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for bidding to contract with an inactive license; and bidding in excess of established license limit. A one-year letter of reprimand was placed in licensee's file; licensee was fined \$1,250 and assessed the cost of investigation.

***Sage Professional Painting Co.***, license number 31864 (Painting and Decorating) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for bidding to contract in excess of established license limit; failure to include license number and monetary limit on a contract or proposal; and failure to comply with a request of the Board for information or records. A permanent letter of reprimand was placed in licensee's file; licensee was fined \$3,500 and assessed the cost of investigation.

*The Nevada State Contractors Board is committed to protecting the public's health, safety, and welfare through licensing and regulation of the construction industry. Under Nevada Revised Statutes, a licensee is subject to disciplinary action by the Board for failure to comply with the requirements of the laws or regulations governing contractors. Violations may result in Board action against the contractor's license. The State Contractors Board has the power to regulate contractors and discipline licensees who violate NRS 624. Disciplinary action may consist of a fine of up to \$10,000 per offense, order corrective action, suspension, revocation or other action.*
