## <u>SEVEN NEVADA CONTRACTORS DISCIPLINED</u> <u>BY CONTRACTORS BOARD</u>

(Reno, NV) – At its meeting on March 12, 2008, the Nevada State Contractors Board adjudicated

cases involving seven contractors.

**D** A Development Incorporated, license number 55592 (Residential & Small Commercial), based out of Minden, NV, was found in violation of Nevada Revised Statute 624 for failure to comply with the regulations of the Board; failure to respond to a written request from the Board; and failure to establish financial responsibility. The licensee was fined \$400, ordered to pay investigative costs submit to a business review. The license remains cancelled.

*Riley Concrete, Inc.,* license number 57916 (Concrete Contracting), based out of Reno, NV, was found in violation of Nevada Revised Statute 624 for substandard workmanship; failure to comply with the Board's notice to correct; failure to include the Residential Recovery Fund information on a contract or proposal; and acting in the capacity of a contractor beyond the scope of the license. The licensee was fined \$200, ordered to pay investigative costs and pay \$1,800 in restitution to the homeowner.

*James David Goldberg, dba Westland Construction,* license number 20727 (Residential & Small Commercial), based out of Gardnerville, NV, was found in violation of Nevada Revised Statute 624 for substandard workmanship; failure to comply with the Board's notice to correct failure to include the Residential Recovery Fund information on a contract or proposal; and failure to establish financial responsibility. The licensee was fined \$2,600 and ordered to pay investigative costs, pay \$9,700 in restitution to the damaged party, remove a lien and reimburse the Board for any monies paid out of the Residential Recovery Fund. The license was revoked.

*Corbet Weiler Homes, LLC.* license number 60222 (General Building), based out of Carson City, NV, was found in violation of Nevada Revised Statute 624 for diversion of funds; failure to respond to a written request from the Board; failure to include the monetary license limit and license number on a contract or proposal; and failure to establish financial responsibility. The licensee was fined \$2,000 and ordered to pay investigative costs, pay \$7,086.70 in restitution to the damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund. The license was revoked.

## Summary Suspensions

The Nevada State Contractors Board took proactive action on March 12, 2008, by summarily suspending the following licenses, after multiple money owning complaints were received on each company:

*Maya LLC, dba Avante Homes,* license number 39906 (General Building), based out of Las Vegas, NV.

*R L Homes, LLC*, license number 68055 (Residential & Small Commercial), based out of Las Vegas, NV.

*Whitewater Pools of Las Vegas,* license number 57218 (Commercial & Residential Pools), based out of Washington, Utah.

The Nevada State Contractors Board is committed to promoting the public confidence and trust in the competency and integrity of licensed contractors and to protecting the health, safety and welfare of the public.

**\*\***The Business Review Program is one in which a contractor's business practices and regulatory compliance is examined by NSCB investigative staff. The program is a part of NSCB's proactive investigative efforts.

The Nevada State Contractors Board is committed to protecting the public's health, safety, and welfare through licensing and regulation of the construction industry. Under Nevada Revised Statutes, a licensee is subject to disciplinary action by the Board for failure to comply with the requirements of the laws or regulations governing contractors. Violations may result in Board action against the contractor's license. The State Contractors Board has the power to regulate contractors and discipline licensees who violate NRS 624. Disciplinary action may consist of a fine of up to \$10,000 per offense, order corrective action, suspension, revocation or other action.
