## BOARD CITES 19 SUSPECTED UNLICENSED CONTRACTORS

**HENDERSON, Nev.** – The Nevada State Contractors Board issued citations to 19 suspected unlicensed contractors during two January undercover sting operations in Henderson and Sparks, Nev. Board investigators cited suspects for contracting without a license and/or illegally advertising construction services. Both are violations of Nevada Revised Statutes Chapter 624.

Investigators identified suspects through complaints to the Contractors Board and by examining advertisements on Craigslist and other bulletin board services. Unlicensed individuals are not allowed to advertise for construction work, which requires a contractor's license. Nevada requires contractors to be licensed to perform any electrical, plumbing, heating or air conditioning work, any construction work that requires a building permit and any project with a value of \$1,000 or more, including labor and materials. Suspects who submitted estimates for work in the prohibited trades or in excess of the \$1,000 ceiling received contracting without a license citation.

At least two of the suspects have criminal records and at least one has been previously cited by the Contractors **Board** 

"We appreciate the cooperation we receive from Nevada homeowners, the state's licensed contractors and local law enforcement as we work to stamp out illegal contracting," said NSCB Executive Officer Margi Grein. "The Henderson Police Department and Washoe County Sheriff's Office provided valuable support for this operation, demonstrating our agencies' shared commitment to protect Nevada's homeowners and legitimate contractors."

The Board's criminal investigators conducting stings used the interactions to educate suspects and offer encouragement and resources to help them to obtain a contractor's license.
