CONTRACTORS BOARD REVOKES LICENSES; ASSESSES \$15,000 IN FINES AT MAY DISCIPLINARY HEARINGS

RENO and HENDERSON, Nev. – The Nevada State Contractors Board took disciplinary action against licensed contractors for violations of Nevada Revised Statutes Chapter 624 during its May hearings. To comply with social distancing and related emergency directives, all Board hearings are conducted online via Zoom, in compliance with Open Meeting Law requirements.

THERESA STRONG aka TERRY STRONG KITCHEN AND BATH (unlicensed)

| Violation | Common Description |
|------------------|---|
| NRS 624.700(1) | Engaging in business or acting in the capacity of a contractor without an appropriate contractor's license. |

Fine of \$1,000 and investigative fees and costs assessed.

K&M CONSTRUCTION dba COOLER DAYS (70826)

| Violation | Common Description |
|-----------------------|---|
| NRS 624.301(2) | Abandonment, insufficient work |
| NRS 624.3017(1) | Substandard workmanship |
| NRS 624.3011(1)(b)(1) | Failure to adhere to the State's building laws |
| NRS 624.3015(1) | Acting beyond the scope of a license |
| NRS 624.301(1) | Abandonment of a construction project |
| NRS 624.3013(3) | Failure to demonstrate financial responsibility |

Fine of \$6,250 and investigative fees and costs assessed. License revoked.

ETERNAL PLUMBING SOLUTIONS (81678)

| Violation | Common Description |
|-----------------------|---|
| NRS 624.302(5) | Failure to cooperate with an investigation of the Board |
| NRS 624.3011(1)(b)(4) | Failure to maintain Industrial Insurance |

Fine of \$750 and investigative fees and costs assessed. License was voluntarily surrendered.

MIKE'S PRO HANDYMAN aka MICHAEL SERWICKI (unlicensed) – Reconsideration Hearing

| Violation | Common Description |
|------------------|---|
| NRS 624.720(1) | Unlawful advertisement of construction services that require a contractor's license |

The Decision and Order from the March 17, 2021 hearing was affirmed in its entirety. Fine of \$3,000 and investigative fees and costs assessed.

MAINLINE MAINTENANCE, LLC (78116)

| Violation | Common Description |
|-----------------------|---|
| NRS 624.3013(4) | Failure to maintain a bond |
| NRS 624.3011(1)(b)(4) | Failure to maintain Industrial Insurance |
| NRS 624.3013(5) | Failure to maintain a Nevada Business license |
| NRS 624.3013(3) | Failure to demonstrate financial responsibility |

Fine of \$4,000 and investigative fees and costs assessed. Licenses revoked.

The Nevada State Contractors Board is committed to protecting the public's health, safety, and welfare through licensing and regulation of the construction industry. Under Nevada Revised Statutes, a licensee is subject to disciplinary action by the Board for failure to comply with the requirements of the laws or regulations governing contractors. Violations may result in Board action against the contractor's license. The State Contractors Board has the power to regulate contractors and discipline licensees who violate NRS 624. Disciplinary action may consist of a fine, order corrective action, suspension, revocation or other action.

NRS 624.212(7) allows an unlicensed individual who was issued a cease and desist order to petition the Board in writing to lift or alter the order within 15 days after receiving the cease and desist order. Upon receipt of this request, the Board will schedule an administrative hearing to review the facts and make a determination on the validity of the cease and desist order and assess any fines or costs that may be associated with the investigation.
