## GOVERNOR SISOLAK APPOINTS VINCENT TATUM TO COMMISSION ON CONSTRUCTION EDUCATION

LAS VEGAS and RENO, NEV. – Governor Steve Sisolak has announced the appointment of Vincent Tatum to the Commission on Construction Education. Mr. Tatum's term is effective December 1, 2022 through November 30, 2025.

"The Commission on Construction Education welcomes Mr. Tatum and the expertise he brings to the Commission," NSCB Executive Officer Margi Grein stated. "We are confident his diverse construction and development background will serve the Commission well."

Tatum is President of Grand Canyon Development Partners. During his career, he has served in management positions in key industry areas, such as commercial construction, project management, capital investment management, risk management, logistics and more. He works closely with key stakeholders, development team members, third-party vendors and suppliers, as well as many more on the projects he oversees. Tatum's unique background includes operations-based logistics and procurement for the U.S. Army as well as experience in working within publicly-traded corporate environments where he managed capital expenditures for large development projects.

The Commission is comprised of seven members who take on a number of responsibilities, including:

- Improving employment opportunities by awarding funds to projects that are expected to increase participation in construction training and credentialing programs;
- Monitoring the results, quality control, management, and viability of any program or events funded in part by Commission grants; and
- Ensuring that grant awards are not used to replace other sources of funding.
