## CONTRACTORS BOARD REVOKES TWO LICENSES DURING JANUARY DISCIPLINARY HEARINGS

*LAS VEGAS and RENO, NEV.* – The Nevada State Contractors Board took disciplinary action against licensed contractors for violations of Nevada Revised Statutes Chapter 624 during its January hearings, including two license revocations and multiple assessments of fines and costs.

Disciplinary action may consist of a fine, order corrective action, suspension, revocation or other action.
