CONTRACTORS BOARD CRIMINAL CITATIONS IN OCTOBER RESULT IN \$24,000 CONSUMER RESTITUTION

(Southern Nevada)

During the month of October, the Nevada State Contractors Board investigated 106 complaints of unlicensed contractors in Southern Nevada. Charges of contracting without a license have been filed against 48 individuals. As a result of the investigations, **\$24,069 in restitution to consumers** was ordered in October 2002.
