Dangers of Hiring Unlicensed Contractors

We all can understand that many people are struggling in these

are struggling in these tough economic times. However, seniors need to be extra cautious when it comes to unlicensed contractors, as unlicensed contractors will try to use an array of tactics to scam seniors.

One tactic commonly used by unlicensed contractors is the "discount" tactic. These unlicensed contractors will try to entice seniors to enter into an agreement by giving them a large discount on projects, such as 50 or 60 percent off the initial price, if they give them the money upfront.

What often happens is seniors will pay these unlicensed contractors upfront, and the unlicensed individuals will do little or no work at all. Oftentimes, their workmanship is shoddy, so seniors are left with a project that needs to be repaired or entirely redone.

Another tactic used by unlicensed contractors is the "life-safety or scare" tactic. For example, unlicensed individuals will inform seniors that, if they don't fix their electrical wirings, their homes will burn down, when in actuality that really isn't the case. They try to pressure seniors by instilling fear in their minds.

Seniors should be wary of unlicensed contractors, as they don't carry workers' compensation insurance.

If you hire an unlicensed To report an unlicontractor who gets injured on your property, you may be held liable for his or her injuries because he or she doesn't carry workers' compensation insurance.

Overall, seniors take a risk if they hire unlicensed contractors. Many unlicensed contractors are not qualified to perform work in trades that require licenses. Their work is often substandard and can pose serious safety issues to homeowners.

Always make sure the contractors whom you hire are licensed in order to avoid problems down-the-line.

The Nevada State Contractors Board (NSCB) has long recognized the vulnerability of seniors to become scammed by unscrupulous individuals in the construction industry and is ready to increase its efforts to raise awareness on

ways they can protect themselves. With over 30 percent of Nevada's population being comprised of individuals 50 years and older, there is an opportunity to reach roughly 822,000 people who are or are close to becoming part of Nevada's senior population through the Senior Awareness Programs.

In partnership with local and state government agency representatives, members of the Legislature and senior groups, NSCB
