Contractors Need To Consider Fed Business Opportunities

You may not know it, but there are many business opportunities available to contractors through the federal government. To take advantage of these opportunities, you should become famil-

iar with the Nevada Commission on **Economic** Development's Procurement Outreach

Program (POP). This state agency, which functions

under a Cooperative

Agreement with the Department of Defense, has offices in Carson City and Las Vegas.

Several federal agencies, termed "Centralized Contracting Activities,"

award contracts regionally, nationally

and worldwide. Examples would be the Army Corp of Engineers (COE), Naval Facilities Engineering Command (NAV-FACENGCOM), the Air Force Center for Engineering Excellence (AFCEE) and the General Services Administration

(GSA) Public Building

Service.

Also, there are "Decentralized Contracting Activities," which are site specific and support internal requirements not satisfied through a centralized

contracting activity. These projects are routinely publicized for bid. Such federal contracts afford companies opportunities to be general contractors

Retail Projects Hot For Northern Nev.

Construction of some of the largest industrial facilities in the history of northern Nevada will drive the building industry through 2007.

The residential market, however, may begin to recover only in the second half of the year. Low vacancy rates in industrial and distribution facilities, continued growth of homegrown companies in Reno and Sparks, and a steady march of new companies into the region have kept requests for proposals flying.

remodeled for the holidays. This year it was limited to no more than 100 applications received between Nov. 14 and Dec. 8, 2006. Applicants were judged on their family's special circumstances.



The Colemans are both retired and disabled. Alvin has been bedridden for several years. Evelyn is a double amputee who goes to dialysis three times a week, due to diabetes complications.

Evelyn moved to Las Vegas in 1954 from Louisiana, where she attended Southern University. She received her masters degree in counseling from UNLV, and worked as a counselor at a prison until retiring. The Colemans raised seven children in their 51-year-old, four-bedroom and one-bathroom home. They have 24 grandchildren.

When asked why they chose to remodel their kitchen, Evelyn said, "Because the kitchen is the heart of a home."

After reviewing nearly 100 applications, Amber Leany, special events coordinator with the Associated Builders and Contractors of Las Vegas, (ABC), said she knew immediately that the Colemans would win.

"With the situations in their lives, everything we were offering, they needed and deserved," Leany said. "Just the fact that we made someone smile makes ABC feel as if we have accomplished a lot."

The Colemans entire kitchen was remodeled from floor to ceiling, all within one week thanks to the volunteers and materials donated by several caring Southern Nevada companies. Clark County Plumbing, Inc. supplied the sink, faucet and did all of the plumbing; Tradewinds Construction donated drywall and did the painting; Helix Electric did all the electrical work; Awesome Floors, Inc. installed the floors; Econ "The Appliance People" donated a new refrigerator and stove; Standard Plumbing Supply Co. donated a water cooler; Republic Services

donated a dumpster; and A-1 mechanical donated their services.

Thomas Chisolm, president of Awesome Floors, Inc. said when he first saw the Colemans' kitchen, he thought it would take a miracle to fix. "To be honest, I didn't think it could be fixed. It needed repairing very badly. It looked like it would be a real challenge, but after all of us contractors worked so well together, the outcome exceeded my expectations."

Chisolm said he decided to volunteer his services because he wanted to give back what was given to him.

"I had to jump at the chance to straighten it out, especially after hearing about the Colemans' disabilities."

Because she is on oxygen, Evelyn

could barely speak the first couple of days during the remodeling. She used oxygen mainly because of mold problems behind the kitchen sink. But once the project was nearing completion, Evelyn was able to speak without the machine.

"I am overjoyed!" she said. "There are people who want things, but I needed this. I needed this."

When asked what her plans were with her new kitchen, she simply replied, "I am going to enjoy it with my family."



License Required To Drill Wells

As the state population grows, one might assume that the Board does not have time to investigate complaints in the rural areas. But this could not be further from the truth. Recently, the Board received complaints concerning drilling of water wells in rural Nevada. Water-well drillers are required to obtain a C-23 classification license. In addition, the Nevada Division of Water Resources has separate license requirements for water well drilling.

Both the Henderson and Reno offices of the NSCB have investigators that investigate criminal and compliance complaints involving the drilling of wells.

Residential Recovery Fund

The 1999 Legislature enacted legislation establishing the Residential Recovery Fund to reimburse homeowners who have been financially damaged by errant contractors. The law requires *all* residential contractors to contribute to the fund and also requires *all* residential contractors to provide a written notice to homeowners in compliance with NRS 624.520

The written statement must be in substantially the following form:

Residential Construction Recovery Fund

Payment may be available from the Residential Recovery Fund, if you are damaged financially by a project performed on your residence pursuant to the contract, including construction, remodeling, repair or other improvements, and the damage resulted from certain specified violations of Nevada law by a contractor licensed in this state. The Board may impose an administrative fine of \$100 for the first offense and \$250 for the second or subsequent offense on the contractor for failing to give appropriate notice.

To assist in compliance with the above statute, residential contractors may provide the above disclosure, when the bid or proposal is submitted, when it is signed, at the time of walk-through, at closing, or when the project is completed.

Contractors Must Notify NDWR For Dewatering

The Nevada Division of Water Resources (NDWR) reminds *all* contractors that if either temporary or permanent dewatering is necessary to alleviate potential hazards from shallow ground water systems for any purpose, NDWR *must be* contacted prior to installation of any dewatering system to ensure that the contractor is in compliance with Nevada Revised Statutes Chapters 533 and 534 and Nevada Administrative Code Chapter 534 inclusive.

on projects.

Another market to consider is "Outsourced Activities," which refer to contracted out functions. Examples in military construction world would be: JOC (Job Order Contracts), SABER (Simplified Acquisition of Base Engineering Resources) and MATOC (Multiple Award Task Order Contracts). This market affords companies the opportunity to perform as a

subcontractor under the general contractor. These contracted-out functions are becoming more popular in today's market. Contractors are strongly urged to understand such business opportunities and position themselves accordingly.

POP also focuses on state, county, city and various commercial marketplaces. It doesn't matter whether you're a general, subcontractor, equipment/material supplier or services provider, these markets exist and are available to you. POP can be your clearinghouse for bid information (e-mailed to you daily), provide one-on-one technical assistance and information on marketing events, workshops, seminars, or help in personalizing your marketing strategies.

Reducing Tax Gap Remains A High Priority For The IRS

To meet its expenses, the federal government needs income, called "revenue," which it raises through taxes.

Taxes provide revenue for federal, local, and state governments to fund essential services—defense, highways, police, etc. Taxes also fund programs that benefit job training, schools and parks.

The Internal Revenue Service developed the concept of the *Tax Gap* as a way to gauge taxpayers' compliance with their federal tax obligations. The tax gap measures the extent to which taxpayers *do not* file their tax returns and pay the correct tax on time. It is the difference between what taxpayers *should have paid* and what they *actually paid* on a timely basis

The tax gap is an estimate of the difference between the individual, corporate, employment, estate and excise taxes that should have been voluntarily paid on time and what was actually paid for a specific year.

The National Research Program (NRP) Individual Reporting Compliance Study, concluded in 2004, examined more than

46,000 individual returns. By analyzing the data, the IRS was able to get a much better picture of how income and deductions were being reported. This information has proven invaluable in a number of ways, including measuring and analyzing the tax gap.

The updated estimate of the overall gross tax gap for Tax Year 2001— the latest year for which data is available— comes to \$345 billion. IRS enforcement activities, coupled with other late payments, recover about \$55 billion of the tax gap, leaving a net tax gap of \$290 billion for Tax Year 2001.


Self-employed individuals and businesses must pay their taxes in regular

installments, known as estimated tax payments. Paying taxes through withholding or estimated taxes during the year helps reduce the government's expense for borrowing money. It also provides an easier method for taxpayers to pay their taxes. The Internal Revenue Service expects all taxpayers to comply with the law voluntarily. Most taxpayers figure out how much tax they are supposed to pay and file their income tax return by the date it is due.

What can you do? Understand and comply with the tax laws, seek assistance when you have a question, and help others in your profession understand the need to comply with the tax laws.



ProLogis, the big industrial developer from the Denver area, is building a 601,000-square-foot industrial building at Tahoe Reno Industrial Center east of Sparks. It's the biggest speculative industrial project ever undertaken in the region. Other developers including DP Partners, Panattoni Development and Trammell Crow Co. also have industrial buildings ranging from 300,000 to 500,000 square feet in the pipeline.

The market for office construction, meanwhile, is continuing to soften.

Demand is soft - particularly as companies involved with the residential real estate business put space back on the market for sublease - and rents haven't risen enough to allow developers to recoup the sharply higher costs of land and the increased costs of

construction materials and labor they've encountered in the past couple of years.

Retail projects, particularly in the fast-growing Spanish Springs area north of Sparks, will be a bright spot for the construction industry through this year. About 1.2 million square feet of retail space was built in Reno and Sparks in 2006, and another 400,000 square feet is currently under way. Well over 2 million square feet of retail projects are in the planning process. Among the high-profile projects on the books are three outdoors-oriented superstores - Cabela's, Bass Pro Shop, and Scheel's - that are expected to make the Reno a major center of outdoors retailing.

The highest profile construction projects in the region continue to be condominiums in downtown Reno, ranging from the new 92-unit, 12-story Palladio to the conversion of the old Sundowner and Golden Phoenix hotel casinos. In downtown Sparks,

meanwhile, construction will begin on The District, a big mixed-use retail and residential project developed by a unit of Trammell Crow.

The new home market, meanwhile, will remain in its funk as inventories of unsold homes are worked off. Observers expect that about 2,500 homes will be started in the region this year compared with the typical pace of 4,000 to 4,400 in recent years. But the inventory of unsold homes in subdivisions continued to decline through the fourth quarter of 2006, and builders say the market could be back into balance by this summer.

Clark County Department of Development Services Notice To The Pool Industry

Pursuant to changes in the Nevada Revised Statutes adopted at the 2005 Legislature, Clark County now requires contractors' employees making connections to residential potable water supply for swimming pools and water features and the installation of gas piping to the pool heating equipment to receive training, obtain a Residential Pool Plumbing Specialist Certification card, and carry the card on their person. The Certification Card will be issued by the Southern Nevada Board of Plumbing Examiners. The effective date of compliance is May 1, 2007.

A Certification Test is required. The test was compiled from current editions of the Uniform Plumbing Code (UPC), the Southern Nevada Swimming and Spa Code, and USA North's Nevada Excavation Manual ("Call Before You Dig"). Commencing on May 12, 2007, the exam will be provided on the second Saturday of every other month.

The test will consist of a 50-question

open-book examination. A complete application must be submitted one month prior to the test date, along with a fee of \$75. Upon successful completion of the examination, a card/photo ID will be issued.

Company Profile

Reno Roofing Nails Success On Strong Work Ethic

Reno Roofing Company is a small family owned business. And that's just the way owners Mark and Dana Reeser want to keep it.

The Reesers started their company in 1997 with just two roofers, running the business out of their home and using a dining room table for an office. They were determined to build Reno Roofing into one of the most reputable and respected businesses in Northern Nevada. Ten years later – with a work ethic of using only quality materials and highly trained installers – the Reesers grew Reno Roofing into a staff of 21 employees who complete an average of 300 roofing jobs per year.

"Our success is that we grew slowly and hired quality men to do the jobs," Dana Reeser says. "Service after the fact is what we offer here. As long as you keep your customers informed, you don't have any problems."

"We don't plan to get any bigger," Mark adds. "We manage this company so we will be at a size where we can manage the amount of customers we take on."

The Reesers say educating homeowners on roofing materials compatible to the areas they live in and proper installation are key to Reno Roofing's success. The Reesers won't do partial roof repairs because they don't believe homeowners benefit in the long run, when other sections of their roof need repairs. And the Reesers only use composite fiber-glass shingles that are fire resistant and that will withstand Northern Nevada's winters and high winds.

A properly installed roof could last between 13 and 25 years, Mark says, adding that snow, wind and UV rays are what's hard on roofs. But Mother Nature really isn't a factor, they say, if a roof isn't properly installed in the first place. Signs of a bad roof installation include shingles not laid in straight lines, excessive nails through the overlaps and nails (referred to as shiners because they glisten in the sun) in fields of shingles.

Mark recommends that homeowners pre-qualify roofing companies before any work begins. Demand that a prospective roofer be on time and polite and that he

carries proof of liability insurance. And also make sure he is a licensed Nevada contractor.

"We offer our customers proof of liability insurance with the customer's name on it," Mark says. "This will go out to any customer who requests proof of liability insurance."

Other signs of a good roofing company are whether, or how fast, they get back to you after the job is finished, the Reesers say. And then there is the warranty issue. Homeowners have four years from the time they sign a contract with a licensed contractor to file a complaint with the Nevada State Contractors Board. The Reesers say they will stand by their work after four years to honor minor repairs.

"We go beyond the warranty because we stand by our workmanship," Mark says. "We did 300 roofs last year and only had 15 call backs."

"You need to be asking questions before you get that roof up there," Dana quickly interjects. "Otherwise, when you start having problems, it's too late."

Lenny Cook, aka Selimoa Finau, Tom Cook and Tom Tuipulotu, dba TC Concrete and Tree Service, contracted to perform concrete, carpentry and landscaping at several Reno residences from October 2004 to June 2005. He was prepaid to do work and either failed to do any work, or did minor work before abandoning the projects. Cook received \$23,000 from homeowners and diverted \$9,000 to other purposes. He has a felony warrant issued by Reno Justice Court for two counts of *diversion of funds*.



Did You Know?

- Contractors are required to advise the Board of any change of address within 30 days. (NAC 624.710)
- The license of a sole proprietor is automatically suspended upon the death of the sole proprietor. (NAC 624.650)
- A license may be placed inactive for a period of up to 5 years. (NAC 624.635)
- Contractors have 10 days to notify the Board when a qualified employee (Q.E.) has terminated employment or association, and 30 days to replace the Q.E. (NRS 624.285)
- A pool contractor may not be related to the construction control company or to an agent of a construction control company. (NRS 624.960)
