

Safety Is The Bottom Line

With the development of City Center by Perini and MGM/Mirage and Boyd Gaming's Echelon property, construction in Nevada has experienced a major boom – one that also brings to light the constant issue of jobsite safety.

Lack of safety on a jobsite is a culmination of different errors and issues that can be avoided:

Lack of Knowledge - Project managers and safety officers need to update their safety postings and education annually. Safety officers need to attend safety workshops and take advantage of the free OSHA services provided.

Although the safety officer and project



manager may be current on safety practices and how to operate safety gear, the crew must be given the same information in a timely fashion.

Faulty or Out-dated Safety Equipment - In many accidents on large projects, fault is not necessarily due to negligence of employees or lack of

LP-Gas Board Licensing Fees Reduced

Any business that has a license with the Nevada State Contractors Board and installs or services any installation supplied, or to be supplied with LP-Gas, is also required to be licensed with the LP-Gas Board. These statutes and regulations have been in force for more than 50 years and can be reviewed on the board's website at: www.lpg.nv.gov.

As part of the licensing process, the board requires all licensees to have a Qualified Person (QP) in supervisory authority who is attached to their business. The QP must demonstrate that he or she has the skills necessary to perform LP-Gas

installations by obtaining a *certificate of competency* (COC) from the board by successfully completing a trade examination specific to their license type.

Many contractors may not know that the LP-Gas Board modified its regulation (NAC 590.240) to reduce annual costs associated with renewing the QP requirements by 61 percent. The board, at the time, was not aware of a typographical error, which resulted in the Class 3A license (a business engaged in the installation or repair of LP-Gas vapor piping, appliances or venting) classification being omitted from the QP requirements.

safety training. We find that equipment used to protect lives is often out-dated or not properly tested. There are companies that give safety demonstrations on site, so workers can understand how a harness works when it counts the most. Remember to replenish your safety gear, and make sure everything is in working order.

Arrogance - It will never happen to me. Some crew members who have been working in the field a long time without safety gear or training may think it is not necessary. Safety has nothing to do with the skill or training of a crew. Accidents are just that - *accidents*. No matter how skilled, educated, or how long you've been in the field, every worker can fall prey to an accident.

Communication - You should have staff/crew or laborers who speak other languages. It is the responsibility of

management to ensure their employees understand the safety laws. All safety information is available in Spanish and French. A bi-lingual staff person is also helpful. Many people speak English, but reading comprehension is another issue. Make sure that every person reads and understands your safety policy.

There are many resources that are available to contractors who want to make their work environment safe. Contact OSHA directly. They will be happy to offer their services for free to educate you and your staff. Risk management groups are always helpful in assessing the needs of your company and jobsites. The College of Southern Nevada, Associated General Contractors (AGC), Nevada Minority Business Council and the Nevada State Contractors Board offer low-cost or free safety classes.

Every accident is usually a

culmination of many factors that could have been avoided. By being aware of these factors, your jobsite becomes a safer workplace. The bottom line is you will save money, insurance costs and your reputation. Continued success hinges on the attention you pay to safety.

The board is currently working to correct this oversight. For now, this creates an opportunity to save \$240 (54 percent) off the initial license application fees of a Class 3A license.



The board recently started a campaign to educate building departments on the licensing requirements of persons applying for building permits that involve LP-Gas installations. Some contractors, who were not licensed with the LP-Gas Board, became aware of this the hard way, when the building department asked to see a copy of their LP-Gas licenses before they would issue a permit.

If you are currently operating without a required LP-Gas license, now is the time to obtain your license, save \$240 and prevent any delays in obtaining a required building permit.

written, or deals inked as to who would be awarded the next big contract. So, how does a MBE or WBE get the opportunity to bid, or at least be thought of when projects are conceived?

Here are some basics: 1) Maintain a well-thought-out and thoroughly written business/financial plan; 2) Display demonstrable execution with talented people and technology; 3) Have knowledge of the game rules (seek quality advice via a lawyer, accountant and mentor); 4) Invest your own capital. You've got to have some skin in the game; 5) Prepare for disappointment (you can draw strength from failure); 6) Be open to partnering and aligning with other MBEs or WBEs; 7) Don't be afraid of the 800-pound gorilla, but recognize your own limitations; 8) Give back. Be a role model or mentor.

Once you've gotten the basics out of the way, do your homework. Identify who the players are: organizational decision makers, i.e., project managers, budget owners, general contractors, construction managers, sub-contractors, your competition and their projects.

Know more about your prospect than they know about themselves. Utilize available resources: internet, annual reports, 10-K reports, perform property site visits and utilize your personal acquaintances. This next point is viewed as a waste of time and perceived as meaningless, however, I can assure you that there is value in registering as an interested supplier on a corporate website. Follow recommendations and submit required documentation. One common mistake to avoid is being a "jack of all trades" to get your foot in the door. Focus on what you do well and network, network, network.

Remember this: *There are three types of people in life: 1) Those on the field making things happen; 2) Those in the stands watching things as they happen; 3) Those outside the arena asking "what just happened?"*

And although you know people, do they really know you?

Industrial, Distribution Centers Bright Spot For Northern Nevada Construction Industry

No one predicts a busy year for the construction industry in northern Nevada — the housing downturn simply is too steep — but industrial and infrastructure jobs will help the industry weather the storm.

During the first 11 months of 2007, the number of residential building permits in Washoe County and Carson City fell by more than 46 percent from the numbers recorded a year earlier — and the year earlier figures were no great shakes to begin with.

Sluggish residential development is likely to continue, at least until the second half of 2008. By one appraiser's count, the inventory of new and existing homes on the market in the Reno-Sparks region is sufficient to meet demand for 15 months, values of residential land have fallen by 30 percent since 2005 and many residential builders are strapped for cash.

But Northern Nevada continues to attract a steady stream of industrial and distribution employers, and workers in those plants need homes. That demand, builders believe, will steadily work down standing inventories.

Those new industrial and distribution facilities, meanwhile, provide a bright spot for the region's construction industry. Some of the largest industrial buildings ever constructed in the region — ranging from 400,000 square feet to nearly 900,000 square feet — are under way at Tahoe Reno Industrial Center east of Sparks, at Stead and Spanish Springs on the northern fringes of the metropolitan area and at Fernley.

Commercial real estate experts note

that the flurry of projects is bringing a record amount of new space to the market, and some worry that a national recession could bring the activity to a screeching halt. Developers, however, say they continue to field a large number of requests for proposals from companies looking to locate new or expanded facilities in Northern Nevada.

In rural areas, mining companies will take advantage of sharply higher gold prices to undertake expansion of their facilities. Barrick Gold, to cite one example, plans three major expansion projects in coming months.

Another bright spot is infrastructure work as cities and utility providers scurry to catch up with demands placed on their systems by five years of rapid growth. Construction of a \$50 million baseball stadium in downtown Reno is expected to start this year, and the stadium is project-

ed to spur numerous retail and mixed-used projects in the downtown region.

NDOT will also be a major player, as its major I-580 project south of Reno and Carson City bypass projects continue.

On the retail front, the big story of 2008 will be construction of The Legends at Sparks Marina, more than 1 million square feet of retail and entertainment space created by RED Development of Kansas City. But other retail construction activity is slowing in response to the housing slump.

Construction of new office buildings — big projects as well as smaller garden offices — is likely to drag as vacancy rates run about 20 percent and lots of space in existing buildings is available for sublease as homebuilders and mortgage lenders pull back.

Stewart Juggles Multiple Tasks For NSCB

When one has worked for the Nevada State Contractors Board as long as Kathy Stewart, both the public and contractors can be reassured that she knows the ins and outs of how the Board functions on a daily basis.

Stewart is the licensing supervisor for our Northern Nevada

office. She has worked at the Board for 20 years and supervises a staff of 11 people.



Stewart oversees the staff that processes new applications. She reviews completed license applications to ensure that they comply with applicable laws and regulations, and also makes certain they are processed in a timely manner.

When evaluating applicants, Stewart says, every applicant is different. Many factors are considered, and she looks at each applicant based on their own merit.

“I think that’s the hardest thing to get across to new employees,” Stewart says. Not every applicant has the same level of experience in a given trade and that is why each application is evaluated differently.

Multi-tasking is nothing new to Stewart. She also manages the bonding department, records department and handles license determinations that allow her to properly classify contractors in appropriate license classifications. She also coordinates staff training, by revising and drafting procedures used to train staff.

“You’re constantly having to shift gears,” Stewart says. A typical day for her is usually “very, very busy.”

Sometimes she feels there aren’t enough hours in a day to complete all of her work.

In overseeing the records department, Stewart assumes responsibility over all case files and handles public requests. She complies with guidelines governing confidentiality of records, but also handles disclosure of information available to the public.

Stewart is responsible for ensuring that all reports on active licensees are sent to various governmental agencies, such as the building departments, the fire marshal and OSHA.

Maintaining balance is the most challenging aspect of Stewart’s job because she has many duties to perform and many people who report to her. Yet being responsible for an array of tasks doesn’t prevent Stewart from enjoying her work. She likes diversity, she says. As trades change and evolve, “You have to evolve with (them),” Stewart says. Things are always changing.

Stewart likes the fact that she isn’t doing the same work day-in and day-out. “It’d be boring if you did the same thing every day,” she feels.

In evaluating license determinations, Stewart likes conducting research, by calling

applicants to get more information, utilizing online search engines and working with investigators to find information.

Stewart is very grateful for the experience she has gained working at the Board. “I’ve worked with so many good people over the years,” she says.

Stewart was born and raised in Sacramento, CA. When she was in high school, after school she worked at an electrical wholesale business her family owned. She moved to Reno to attend college and never returned to California. She has enjoyed living in Northern Nevada for the past 27 years.

Stewart has been married for about 25 years and has two children. Her 22-year-old daughter is a graduate student at the University of Nevada, Reno (UNR), and her 18-year-old son is an undergraduate student at UNR. Her hobbies include gardening, reading and renovating her home.

Board Institutes Qualified Employee Verification

The Nevada State Contractors Board is responsible for ensuring that all contractor license records contain accurate and up to date information.

Commencing in 2008, we have instituted a **“Qualified Employee Verification”** form for each licensee’s “Qualified Employee” to complete. The completed form will be provided with your contractor license renewal application, and each person listed on the renewal as a “Qualified Individual” must complete a

verification form. You may be required to make copies of the form, if you have more than one qualified individual.

The purpose of requesting the “Qualified Employee Verification” is to confirm that each person who has been designated “Qualified Employee” of a licensee is knowledgeable of the Qualified Employee responsibilities outlined in Nevada Revised Statute (NRS) 624.260.

In addition, if a “Qualified Employee” is no longer associated with, or employed by

the licensee for whom he qualifies the license, the Board must be notified in writing within 10 days under the provisions of NRS 624.285.

We appreciate your cooperation in completing the “Qualified Employee Verification” to help our office ensure that the license records on file with the Board are complete and contain correct information.

Get All Your Ducks In A Row With Bonding

Bonding is one of the main issues contractors will face at one point or another. It really doesn't matter whether you are a newly licensed contractor, or have been in business for many years. You may be asked for a bond. Usually it starts with a contractor's license bond, which confirms your license is current and active.

For some construction projects that are either residential or commercial, you may need to provide a bid, performance and

completion bond in order to be considered to bid. Typically this is called a bond facility.

You may ask yourself, "Why do I need it? Where do I get it, and who do I get it from?"

Let's first look at what a bond is. It is not insurance. It is surety. So what does that



mean? There are three parties who are involved in a bond. First there is the "Principal," or person requesting the bond. In most cases, it is the general contractor who is asking you for the bond. This is a way for the general contractor to hire sub-contractors who are capable of doing the work from start to finish, and make sure the project is completed on time and within budget. Some contractors will allow you to recover the cost of your bond by including it in your bid.

The second party is the "Obligee." That means you, the contractor purchasing the bond and the one obliged to complete work as outlined in your contract. If you fail to complete the work, your bond may be used to cover the cost of someone else completing the work.

The third party in this arrangement is the "Surety." This is the bonding company that will pay on your behalf, if you fail to perform your duties under the contract. To purchase a bond, you need to first ask your current property and casualty insurance agent or broker if they can place the

bond for you. If not, you will need to find a qualified agent or broker who can. Bonding will require the completion of a comprehensive application, and in many cases financial information from your business and personal finances. Typically, the bonding company is looking at your character, your capitol and your capacity to perform the work. If you have a history of complaints, bad finances and too much work, you may not be bondable. In some cases, you may be required to post a letter of credit, have cash in the bank or use personal property as collateral in order to be bonded. These requirements also dictate what dollar limit you may be bonded.

Not all contractors will want to work on projects that require bonds, and there will be many who don't qualify for bonding. For contractors who want to work on bonded projects and who meet the criteria, there are many opportunities to bid on projects throughout Nevada.



Failure to respond to an Administrative Citation will result in the automatic suspension of the license!

Knowingly entering into a contract with an unlicensed contractor, or knowingly entering into a contract with a licensed contractor outside the monetary limit or scope of the licensed contractor may subject you to a fine of \$50,000!
