## ADMINISTRATIVE CODE 624 RELATING TO CONTRACTORS

LAS VEGAS and RENO, NEV. – On December 21, 2021, The Nevada Legislative Commission approved two revised regulations of Nevada Administrative Code (NAC) 624 relating to contractors. R022-21 modifies NAC 624.7251 to create fine ranges for new disciplinary violations created or amended during the 81<sup>st</sup> Session of (2021) of the Nevada Legislature, and makes conforming changes to NAC 624.6932. R030-21 amended NAC 624 by adding standards for advertisements related to residential photovoltaic systems.

"The Board's work during the 2021 Nevada Legislature provided added safeguards for the public and helped to level the playing field for contractors," stated Nevada State Contractors Board Executive Officer Margi Grein. "These regulations provide the technical details to finalize the intent of the legislation."

R022-21 updates the administrative fines laid out in the existing regulation to create fine ranges for new disciplinary violations created or amended during the 2021 legislative session by Assembly Bill (AB) 51, AB 227, and Senate Bill (SB) 303.

R030-21 amends Chapter 624 of the NAC to comply with the provisions of SB 303 which require the agency to adopt by regulations standards for advertisements concerning residential photovoltaic systems used to produce electricity. The proposed regulation:

- 1. Prohibits a contractor from engaging in deceptive advertising or "bait and switch" advertising regarding work with residential photovoltaic systems used to produce electricity; and
- 2. Describes the acts which constitute such prohibited advertising.
