13 CONTRACTORS DISCIPLINED **BY CONTRACTORS BOARD**

HENDERSON & RENO, Nev. – At its April 2012 meetings, the Nevada State Contractors Board adjudicated cases involving 13 contractors.

Evans Homes, Inc., license number 45931A (Residential & Small Commercial), based out of Minden, Nev., was found in violation of Nevada Revised Statute 624 for failure to include the Residential Recovery Fund information on a contract or proposal. The licensee was fined \$100. The license limit was lowered to \$245,000.

Peek Construction Company, license number 62283 (General Engineering); **Williams Brother, Inc.**, license numbers 59537 and 60631 (Electrical Contracting and General Engineering), based out of North Las Vegas, Nev., were found in violation of Nevada Revised Statute 624 for failure to pay any money due for any materials or services rendered; and failure to establish financial responsibility. The licensee was fined \$5,500 and ordered to pay investigative costs. The licensee shall voluntarily surrender the licenses.

Daniel Scott Larson, dba Southwestern Construction, license numbers 69555 and 74852 (Residential & Small Commercial), based out of Anaheim Hills, Calif., was found in violation of Nevada Revised Statute 624 for willful disregard of the safety laws or labor laws of the state; and failure to establish financial responsibility. The licensee was fined \$1,500 and ordered to pay investigative costs. License number 74852 shall remain suspended until a financial statement with a bank verification is provided.

A K Designs, LLC., dba Accent Windows, license number 74003 (Glass & Glazing); **Accent Window, Inc.**, license number 54045 (Glass & Glazing), based out of Sparks, Nev., were found in violation of Nevada Revised Statute 624 for failure to establish financial responsibility; and failure to respond to a written request from the Board. Accent Window, Inc., was fined \$750 and ordered to pay investigative costs. The licenses were revoked.

J Z L Designs, license number 51870 (Finish Carpentry), based out of North Las Vegas, Nev., was found in violation of Nevada Revised Statute 624 for failure to take appropriate corrective action; failure to include the Residential Recovery Fund information on a contract or proposal; and failure to

establish financial responsibility. The licensee was ordered to pay \$4,031.24 in restitution and provide a financial statement with a bank verification.

Masoncraft Tile & Masonry, LLC., dba Masoncraft Pool Builders of Las Vegas, license number 74549 (Excavating and Grading and Commercial & Residential Pools); **Masoncraft Tile & Masonry, LLC.**, license numbers 70438, 70439, 75063 and 73626 (Masonry, Tiling, Concrete Contracting and Plumbing), based out of Las Vegas, Nev., were found in violation of Nevada Revised Statute 624 for failure to include the Residential Recovery Fund information on a contract or proposal; failure to provide the name, license number, business address and telephone number of all subcontractors and persons who furnish material of \$500 or more for the project, failure to provide a pre-lien notice to the owner and failure to provide customers with required "Notice to Owner" disclosures concerning laws governing contractors and lien laws; willful disregard of the building laws of the state; failure to include the monetary license limit or license number on a contract or proposal; and failure to keep in force a bond or cash deposit. The licensee was fined \$1,750 and ordered to pay investigative costs.

Republic Crane Service, LLC., license number 67299 (Rigging & Cranes); **American Crane & Hoist Erectors, LLC.**, license number 67635 (Elevator & Dumbwaiter); **Republic Crane & Hoist Service, LLC., dba Liberty Crane & Hoist Service**, license number 75707 (Rigging & Cranes), based out of Henderson, Nev., were found in violation of Nevada Revised Statute 624 for failure to establish financial responsibility; and failure to respond to a written request from the Board. The licensee was fined \$750 and ordered to pay investigative costs. The licenses were revoked.

Nevada Floor Tech, Inc., license number 54414A (Covering Floors), based out of Las Vegas, Nev., was found in violation of Nevada Revised Statute 624 for substandard workmanship; failure to take appropriate corrective action; failure to respond to a written request from the Board; failure to include the monetary license limit or license number on a contract or proposal; and failure to establish financial responsibility. The licensee was fined \$2,000 and ordered to pay investigative costs. The license was revoked.

JD M Tech, Inc., dba Las Vegas Home Technology, license number 73758 (Low Voltage), based out of Las Vegas, Nev., was found in violation of Nevada Revised Statute 624 for failure to comply with the terms of a construction contract thereby causing material injury to another; abandonment without legal excuse of any construction project; contracting on an inactive license; failure to respond to a written request from the Board; failure to include the Residential Recovery Fund information on a contract or proposal; failure to include the monetary license limit or license number on a contract or proposal; failure to provide the name, license number, business address and telephone number of all subcontractors and persons who furnish material of \$500 or more for the project; and failure to establish financial responsibility. The licensee was fined \$4,250 and ordered to pay investigative costs. The license was revoked.

Ground F X Custom Concrete, LLC., license number 69271 (Concrete Contracting), based out of Las Vegas, Nev., was found in violation of Nevada Revised Statute 624 for substandard workmanship; failure to take appropriate corrective action; failure to include the Residential Recovery Fund information on a contract or proposal; failure to include the monetary license limit or license number on a contract or proposal; misrepresentation of a material fact; and failure to establish financial responsibility. The licensee was fined \$2,500 and ordered to pay investigative costs. The license was revoked.

Southwest Renovations, LLC., dba Mak Construction, license number 74452 (Carpentry), based out of Las Vegas, Nev., was found in violation of Nevada Revised Statute 624 for substandard

workmanship; failure to take appropriate corrective action; failure to respond to a written request from the Board; failure to include the Residential Recovery Fund information on a contract or proposal; willful disregard of the building laws of the state; acting in the capacity of a contractor beyond the scope of the license; failure to notify the Board of a change in personnel or address within 30 days of the change; failure to keep in force a bond or cash deposit; and failure to establish financial responsibility. The licensee was fined \$4,250 and ordered to pay investigative costs. The license was revoked.

Clark County Contract Services, license numbers 72819 and 74489 (Painting & Decorating and Residential & Small Commercial), based out of Las Vegas, Nev., was found in violation of Nevada Revised Statute 624 for substandard workmanship; failure to take appropriate corrective action; failure to respond to a written request from the Board; failure to include the monetary license limit or license number on a contract or proposal; accepting a bid from an unlicensed person; aiding or abetting an unlicensed person and combining or conspiring with an unlicensed person to perform an unauthorized act; acting in the capacity of a contractor beyond the scope of the license; misuse of a license; advertising beyond the scope of the license; misrepresentation of a material fact; and failure to establish financial responsibility. The licensee was fined \$4,250 and ordered to pay investigative costs. The licenses were revoked.

Design Landscape Corporation, license number 68561 (Landscape Contracting), based out of Las Vegas, Nev., was found in violation of Nevada Revised Statute 624 for substandard workmanship; failure to take appropriate corrective action; failure to respond to a written request from the Board; and failure to establish financial responsibility. The licensee was fined \$1,750 and ordered to pay investigative costs. The license was revoked.

****The Business Review Program is one in which a contractor's business practices and regulatory compliance is examined by NSCB investigative staff. The program is a part of NSCB's proactive investigative efforts.**

The Nevada State Contractors Board is committed to protecting the public's health, safety, and welfare through licensing and regulation of the construction industry. Under Nevada Revised Statutes, a licensee is subject to disciplinary action by the Board for failure to comply with the requirements of the laws or regulations governing contractors. Violations may result in Board action against the contractor's license. The State Contractors Board has the power to regulate contractors and discipline licensees who violate NRS 624. Disciplinary action may consist of a fine of up to \$10,000 per offense, order corrective action, suspension, revocation or other action.
