## 17 NEVADA CONTRACTORS DISCIPLINED BY CONTRACTORS BOARD

(*Henderson, NV*) – At its meetings on Feb. 25, 2009, the Nevada State Contractors Board adjudicated cases involving 17 contractors.

*Bangle Enterprises, Inc.*, license number 17956A (Residential & Small Commercial) based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for substandard workmanship and failure to include the Residential Recovery Fund information on a contract or proposal. The licensee was fined \$1,100 and ordered to pay investigative costs.

Mizrachi Construction, dba Abes Construction, license numbers 53120 and 68383 (Lathing & Plastering and Residential & Small Commercial), and Salmiz, Inc., dba Global Flooring, license number 69893 (Covering Floors and Carpet Laying) based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for substandard workmanship; failure to take appropriate corrective action; failure to include the Residential Recovery Fund information on a contract or proposal; failure to include the monetary license limit and license number on a contract or proposal; failure to establish financial responsibility; and for the partnership, corporation, firm or association participating in a prohibited act. The licensee was fined \$1,300; ordered to pay investigative costs; pay \$10,134 in restitution and provide a current financial statement. License number 68383 was suspended.

*North Electric, LLC.*, license number 45374A (Electrical), based out of Las Vegas, was found in violation of Nevada Revised Statute 624 for failure to establish financial responsibility. The licensee was fined \$1,000 and ordered to pay investigative costs and provide a current financial statement. The license was suspended.

Service – 1, Inc., dba Thomas Plumbing Sewer & Drain, license number 37901 (Plumbing & Heating) based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for failure to establish financial responsibility. The licensee was fined \$500 and ordered to pay investigative costs. License limited reduced. The license was suspended.

T.S.L. Enterprises, Inc., dba Ubuildit Henderson, license number 57319 (Residential & Small Commercial), based out of Henderson, NV, was found in violation of Nevada Revised Statute 624 for abandonment of a construction project; failure to include the Residential Recovery Fund information on a contract or proposal; failure to include the monetary license limit and license number on a contract or proposal; substandard workmanship; failure to take appropriate corrective action; failure to keep in force a bond or cash deposit; and failure to establish financial responsibility. The licensee was fined \$2,600; ordered to pay investigative costs and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. The license was revoked.

**Pool, Inc., dba Worldmark Pools & Spas.,** license number 56570 (Commercial & Residential Pools), based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 failure to pay money due for materials or services; failure to take appropriate corrective action; abandonment of a construction project; failure to include the monetary license limit and license number on a contract or proposal; failure to comply with the terms of a construction contract, thereby causing material injury to another; and failure to establish financial responsibility. The licensee was fined \$10,000; ordered to pay investigative costs and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. The license was revoked.

Clark County Services, LLC., license number 62797 (Plumbing), based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for willful disregard of the laws of the state regarding industrial insurance and failure to comply with a written citation. The licensee was fined \$1,000; ordered to pay investigative costs and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. The license was revoked

*Probuilt Services, LLC.*, license number 68032 (Residential & Small Commercial), based out of North Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for diversion of funds; failure to establish financial responsibility and failure to comply with a written citation. The licensee was fined \$1,500; ordered to pay investigative costs and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. The license was revoked.

M.S.I. Landscaping, Inc., license number 49229; M.S.I. Concrete Services, Inc., license number 53653; M.S.I. Development, Inc., license number 62989; Misty Systems International, Inc., license number 44109; and M.S.I. Development, A Division of Mist Systems International, Inc., license number 48359 (Landscaping, Concrete Contracting, General Engineering, Unclassified, and Residential & Small Commercial) based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for failure to respond to a written request from the Board; failure to establish financial responsibility; and for the partnership, corporation, firm or association participating in a prohibited act. The licensee was ordered make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. The licenses were revoked.

*X Treme Plastering, LLC.*, license number 67760 (Lathing & Plastering) based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for failure to comply with a written citation. The licensee was fined \$1,000; ordered to pay investigative costs and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. The license was revoked.

John Richard Gyselaar, dba Air Source Air Conditioning and Heating license number 49494 (Refrigeration & Air Conditioning) based out of Henderson, NV, were found in violation of Nevada Revised Statute 624 for failure to comply with a written citation. The licensee was fined \$1,000; ordered to pay investigative costs; and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. The license was revoked.

Dugan Enterprises, LLC., license number 69342 (Excavating Grading Trenching & Surfacing and Wrecking Buildings), based out of North Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for failure to respond to a written request from the Board; failure to keep in force a bond or cash deposit; and failure to establish financial responsibility. The licensee was fined \$1,500; ordered to pay investigative costs; and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. De La Vega Construction, LLC., license number 63964 (Excavating Grading Trenching & Surfacing), based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for failure to establish financial responsibility. We Gotcha Covered, Inc., license numbers 59416, 58989 60320 and 60321 (Tiling, Finishing Floors, Install Terazzo & Marble and Finish Carpentry), based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for failure to comply with the terms of a construction contract, thereby causing material injury to another; failure to establish financial responsibility; failure to keep in force a bond or cash deposit; failure to notify the Board of a change in personnel or address within 30 days of the change; and for the partnership, corporation, firm or association participating in a prohibited act. The licensee was fined \$2,250; ordered to pay investigative costs; and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. The licenses were revoked.

*M.E.C. Construction, LLC.*, license number 54963 (Residential & Small Commercial), based out of Las Vegas, NV, was found in violation of Nevada Revised Statute 624 for failure to respond to a written request from the Board; failure to establish financial responsibility; and failure to notify the Board of a change in personnel or address within 30 days of the change. The licensee was fined \$1,500; ordered to pay investigative costs; and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. The license was revoked.

Clear Choice Development Group, Inc., dba Thurston Construction license number 60132 (General Engineering), based out of Washington, UT, was found in violation of Nevada Revised Statute 624 for substandard workmanship; failure to take appropriate corrective action; failure to establish financial responsibility; failure to respond to a written request from the Board; and failure to keep in force a bond or cash deposit. The licensee was fined \$2,750; ordered to pay investigative costs; and make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund, plus fines and investigative costs. The license was revoked.

\*\*The Business Review Program is one in which a contractor's business practices and regulatory compliance is examined by NSCB investigative staff. The program is a part of NSCB's proactive investigative efforts.

The Nevada State Contractors Board is committed to protecting the public's health, safety, and welfare through licensing and regulation of the construction industry. Under Nevada Revised Statutes, a licensee is subject to disciplinary action by the Board for failure to comply with the requirements of the laws or regulations governing contractors. Violations may result in Board action against the contractor's licensee. The State Contractors Board has the power to regulate contractors and discipline licensees who violate NRS 624. Disciplinary action may consist of a fine of up to \$10,000 per offense, order corrective action, suspension, revocation or other action.
