Reminder: Residents Welcomed to Attend, Watch Tele-Town Hall on Consumer Protections Related to Solar Scams, Pool Scams, and How to Report a Contractor on July 30

LAS VEGAS, NEV. -- The Nevada State Contractors Board and Clark County Commissioner Marilyn Kirkpatrick are hosting a tele-town hall meeting for residents **from 5:30 to 6:30 p.m. on Tuesday, July 30** on how to protect themselves when purchasing solar panels, swimming pools, as well as the proper steps to take when hiring a licensed contractor for home repair projects. Residents are welcome to attend in-person at the Clark County Government Center, 500 S. Grand Central Parkway, inside the Commissioner Chambers, or watch remotely.

With contractor scams on the rise, representatives from the Nevada State Contractors Board will be on hand to answer questions from attendees, provide tips on "red flags" to look out for to prevent falling victim to solar installation and pool construction scams, and 'how to' information on applying for the Board's Residential Recovery Fund, which offers financial assistance to those harmed by licensed contractors. In addition, there will be a raffle for the chance to win three \$100 gift cards to Home Depot for anyone who attends the meeting in person.

If you are unable to attend the meeting in person you can watch it live from many different sources including, the County's YouTube channel, Facebook page and Clark County Television (CCTV). CCTV is available in the Las Vegas area on Channel 4 on Cox cable as well as in Laughlin on Channel 14 via Optimum. It is also available in Boulder City on Channel 4 and in Moapa Valley on Digital Channel 50.3. One may watch CCTV on streaming devices such as Roku, Apple TV and Amazon Fire TV via the YouTube app.
