Respondent Gilberto Vazquez appears in person and through Tony May, Esq.; Prosecutor Jack Juan, Esq.; Mark Shryock, Compliance Investigator. After testimony and cross-examination of the Respondent and Compliance Investigator, Mark Shryock, the Board recommends that Respondent be found in violation of Allegations 1 through 4, with fines of \$1,000 for each allegation. **THEREAFTER, the Administrative Law Judge ORDERS that the license will remain active, but will be suspended if compliant financials are not provided by February 10, 2025, showing the ability to support at least a \$250,000 monetary limit; Thereafter, if compliant financials are not received by March 15, 2025, license number 79730 will be immediately revoked; That during the next 45 days no new projects will be taken on and the two (2) current projects must be completed by March 15, 2025; Fees and costs will be assessed by the Board will be sent in the form of a Bill of Costs.**

There are no Homeowners present; Respondent does not appear; Prosecutor Jack Juan, Esq.; Carl Hilbish, Compliance Investigator; Mark Shryock, Compliance Investigator. After testimony by Carl Hilbish and Mark Shryock, **the Administrative Law Judge finds good cause appearing through testimony, with records and demonstrative proof of service, ORDERS a Default and the immediate revocation of license number 87037; further that Respondent is found to be in violation of Allegations #1 through #38 with a fine of \$5,000 per each for a total of \$190,000 in fines; that Respondent Gary Michael Briggs is permanently banned and prohibited from conducting business, serving as an officer, director or partner for any licensed company in the State of Nevada; that if any of the Complainant Homeowners make a claim against the Residential Recovery Fund and are granted any amount of money from that claim, that Respondent will be liable for reimbursement of that amount. Further, the ALJ ORDERED that Respondent is liable for ALL fines, fees and costs along with the maximum fines above, totaling \$190,000 which the ALJ will place into the Decision and Order.**




The disciplinary hearing was adjourned by Administrative Law Judge Richard Scotti, Esq. at 1:20 p.m.
