The NSCB has the responsibility to promote quality construction by Nevada licensed contractors through a regulatory licensing system designed to protect the health, safety and welfare of the public."

6. EXECUTIVE SESSION

a. Executive Officer's Report

Mr. Behar reported that, outside of the Board's legislative engagement, several activities have taken place. As part of workforce development efforts, key staff attended an EmployNV Youth Hub presentation to share information about the NSCB work environment and explore opportunities for summer interns — a first for the Board. Mr. Behar noted that a Spanish-focused, interactive advertisement was launched with the Las Vegas Review-Journal as part of the Language Access Plan to better reach Spanish-speaking communities. Mr. Behar further reported that senior seminars are being scheduled in both Northern and Southern Nevada, with plans to partner with state and local representatives on public safety messaging. Mr. Behar commended Director of Investigations Lou Quesada for conducting his first Spanish-language media interview with Telemundo, which provided valuable consumer education. Lastly, Mr. Behar noted that he also participated in the recent CCSD Advisory Board meeting focused on construction technologies, where they highlighted the Construction Education Commission's grant program and discussed opportunities to enhance curriculum and workforce development partnerships. - Approved 744 license renewal applications;

- Hosted 1 online Business Assistance Program with 21 participants in attendance.
- There are currently 1273 license applications and 624 change applications pending.

Our Investigations Department:

- Held 13 Disciplinary Hearings, where 34 cases were heard.
- 9 Recovery Fund claims were opened with no Recovery Fund meetings held in the month of April.

Our Compliance Division:

- Received and opened 106 complaints and closed 201 complaints, issuing 13 Administrative Citations.
- As of April 30th, there are 716 compliance complaints open active with an average of 203 days open.

Our Criminal Division:

- Received 41 complaints and closed 50 complaints, issuing 8 Administrative Citations.
- 2 Criminal cases were sent to the local District Attorney's office.
- 39 Criminal complaints are open-active with the average days open being 36.
- There are 18 pending adjudication in the month of April.
