Complainant, Josephine Nacional appears on behalf of MJ Systems & Design Corporation; Homeowner, Jason A. Frost appears in person; Respondent, does not appear; Prosecutor, Jack Juan, Esq; T.J. Ticano, SIU Supervisor; Raymond Zack, Compliance Investigator. After hearing from the Prosecutor, the Administrative Law Judge (ALJ) finds good cause appearing and conducts a prove-up default hearing. Thereafter, the Administrative Law Judge (ALJ) ORDERS that license number 84883 is immediately revoked; Respondent is in violation of Allegations #1 through #25. The ALJ takes the allegations under advisement to assess the fines for each Allegation. The ALJ finds that Respondent is in violation of Allegation #26 and hereby ORDERS that Respondents, Liopoldo Murrieta-Serna and Leohabin Misael Murrieta-Serna are permanently banned and prohibited from conducting business, serving as an officer, director or partner for any licensed company in the State of Nevada. That if any claims for Residential Recovery Fund are made and are granted any amount of money from that claim, that Respondents will be jointly liable for reimbursement of that amount.

Respondents appear through Juan Mendez, Terry Butterfield and Nestor Mendez; Prosecutor, Jack Juan, Esq.; and Jason Feeley, Criminal Investigator. *After hearing sworn testimony, the Administrative Law Judge (ALJ) finds good cause appearing, and regarding Allegation #1, removes Antonio Ismael Mendez from license number 67057. That Respondent is found to be in violation of Allegations #1 and #2 with fines of \$500 per each, for a total of \$1,000 in fines; that regarding Allegation #3, Respondent is given thirty (30) days to provide compliant financials; the ALJ ORDERS that Respondent is not to take on any new jobs over \$75,000; that the Board's fees and costs will be assessed and a Bill of Costs will be provided to Respondent after the Decision and Order is issued.*

Respondent, Dave Pasco, appears in person; Prosecutor, Jack Juan, Esq.; and Jeff Holland, Criminal Investigator. The parties and investigators are sworn in and testify regarding the allegations. Thereafter, the Administrative Law Judge (ALJ), on the request of the Board, ORDERS immediate revocation of license numbers 90266, 90267, 90268, and 90269; finds Respondent in violation of Allegation #1, with a fine of \$500; in violation of Allegation #2, with a fine of \$500; in violation of Allegation #3 with a fine of \$500. That Respondent is prohibited from completing any current jobs and/or taking on any new jobs. If Respondent does have any open projects, Respondent is to hire a contractor to complete the job(s); Respondent is to pay the fines totaling \$1,500 within thirty (30) days from the date of the hearing; The Respondent is to pay the Board's fees and costs, which will be assessed and a Bill of Costs will be provided to Respondent after the Decision and Order is issued.
