CONTRACTORS BOARD OFFERS WORKSHOPS TO GUIDE INTERESTED APPLICANTS THROUGH RESTRICTED LICENSE OPPORTUNITY

LAS VEGAS and RENO, NEV. – Following the approval of Senate Bill 130 during the recent legislative session, the Nevada State Contractors Board will be hosting two informational workshops to inform and promote a new restricted license opportunity available to interested and qualified individuals seeking to perform remodeling and improvement work on residential structures not exceeding three stories above and one story below ground.

"The NSCB alongside industry and community partners, including the Latin Chamber of Commerce, recognize the value of expanding licensure opportunities to individuals who have a passion for their trade, but lack the years of experience to qualify for a contractor's license on their own. The restricted license is an opportunity for members of our construction workforce to take the next step in their careers, gain the knowledge and experience necessary to obtain a full license, and ensure the protection of the public throughout their journey," explained Executive Officer David Behar.

- About the Event:The NSCB will walk through the requirements for obtaining a restricted
license, provide licensing experts to answer participant questions, and
highlight opportunities for which a restricted license may be used.
- Who should attend:Employers looking for opportunities to promote/expand their workforce.Individuals with at least two years of (a) trade experience; (b) training in aprogram offered at an accredited college or university, apprenticeship orequivalent program accepted by the Board; or (c) completion of any otherprogram or obtaining any other qualification acceptable to the Board.
