Respondent appears in person through Mitch Hamlin, Secretary Assistant and through Jeff Spencer, Esq., Joe Balkenbush, Esq.; Prosecutor, Jack Juan, Esq.; and Fred Schoenfeldt, Investigations Supervisor. The Prosecutor states that there has been an agreement reached. The Administrative Law Judge (ALJ) asks counsel for Respondent to read the agreement into the record. Thereupon, the Board agrees to the terms set forth and suggests that Respondent be found in violation of Allegation #1 and #2, dismissing Allegations #3 and #4.
