GOVERNOR LOMBARDO TO SIGN SB 130 AT PUBLIC EVENT, RECOGNIZING THE INDUSTRY'S ROLE IN PROMOTING NEW LICENSURE OPPORTUNITIES

LAS VEGAS and RENO, NEV. – Executive Officer David Behar will join Governor Lombardo, Senator Fabian Donate, Senator Edgar Flores, Senator John Steinbeck, Latin Chamber of Commerce of Nevada President/CEO Peter Guzman and other dignitaries on Tuesday, September 2, 2025, for a bill signing event on Senate Bill 130. During the most recent legislative session, SB 130 was approved allowing for the creation of a restricted license that permits individuals to perform home improvement projects on residential properties with limitations.

“The Contractors Board appreciates the collaborative effort of many throughout the 2025 Legislative Session to bring forward tangible solutions that expand workforce development opportunities while continuing to prioritize the protection of consumers,” expressed Behar. “We welcome individuals to join the construction workforce under this new restricted license category as they gain the experience and knowledge necessary to achieve a full contractor’s license in the future.”

The event will begin at 1:15 p.m. at the Latin Chamber of Commerce located at 300 N. 13th Street, Las Vegas, Nevada. All who are interested in attending are welcome.

The Board recently held its first SB 130 workshop where nearly 50 people attended at the Las Vegas office receiving information on the new licensure opportunity and application requirements. **A second workshop will be held in the Reno office, 5390 Kietzke Lane, Suite 102, on September 8, 2025 at 10:00 a.m. Anyone interested in applying for the restricted license is encouraged to attend and RSVP as soon as possible as seating is limited.**
