MINUTES OF THE MEETING September 5, 2025

Mr. Behar stated the agenda was posted in compliance with the open meeting law on the Board's Internet Website, the Public Notice Website, both offices of the Nevada State Contractors Board, and e-mailed electronically to persons who have expressed interest in being kept informed of the Board's meetings.

2. STATEMENT OF THE BOARD'S MISSION

Mr. Behar read the Board's mission statement into the record: "The Nevada State Contractors Board is committed to ensuring the integrity and professionalism of the construction industry in Nevada. The NSCB has the responsibility to promote quality construction by Nevada licensed contractors through a regulatory licensing system designed to protect the health, safety and welfare of the public."

3. PUBLIC COMMENT

Mr. Behar recognized Elizabeth Save with a Certificate of Appreciation for her assistance concerning the Board's proactive investigations. Mr. Behar also introduced new employees Patrick Blas and Jennifer Calvillo-Mejia to the Board.

4. APPROVAL OF AGENDA:

Mr. Behar noted that item number 206 (Frank Lepori Construction LLC) on the consent agenda has been removed.

It was moved and seconded to accept the amended agenda. MOTION CARRIED.

Mr. Behar reminded the Board of the Residential Recovery Fund meeting following the Board meeting.

5. APPROVAL OF MINUTES

It was moved and seconded to approve the minutes of August 21, 2025 meeting. MOTION CARRIED.

6. EXECUTIVE SESSION

a. Executive Officer's Report

Mr. Behar noted that he attended the Governor's signing ceremony for SB 130, which was well attended by legislators, Board members, staff, media, and stakeholders, providing an opportunity to highlight the importance of this initiative. He also reported presenting an update on the Board's activities and legislative accomplishments to the Glazing Contractors Association, which allowed for sharing developments, answering questions, and receiving industry feedback. Since the last Board meeting, the Reno investigative unit, in collaboration with the Capitol Police, apprehended unlicensed contractor Jesse Steven Diaz of Battle Born Fence, who was arrested on a felony warrant for theft after taking a cash deposit and abandoning the project; Mr. Behar expressed appreciation for the continued partnerships with law enforcement and the Attorney General's Office in addressing violators. He further announced that the Board will conduct its second SB 130 workshop in Reno on September 8, 2025, following the success of the first workshop in Las Vegas, which was well received by industry members, associations, and contractors.

b. Review of Monthly Department Statistics:

Mr. Behar provided the following statistics for the month of August:

- Licensing Department:
 - Received 285 new license applications and 292 change applications;
 - Issued 134 new licenses;
 - · Approved 680 license renewal applications;
 - Renewed and issued 27 Certificates of Eligibility to receive preference in bidding; and
 - Hosted 1 online Business Assistance Program with 22 participants in attendance.
 - There are currently 1,156 license applications and 590 change applications pending.
- Investigations Department:
 - Held 8 Disciplinary Hearings, where 29 cases were heard.
 - 3 Recovery Fund claims were opened and there was no Recovery Fund meeting held in the month of August.
- Compliance Division:
 - Received and opened 94 complaints and closed 178 complaints, issuing 4 Administrative Citations.
 - As of August 31st, there are 491 compliance complaints open active with an average of 170 days open.
- Criminal Division:
 - Received 40 complaints and closed 157 complaints, issuing 15 Administrative Citations.
 - No cases were sent to the local District Attorney's office.
 - 67 Criminal complaints are open-active with the average days open being 74.
 - · One case is pending adjudication in the month of August.
