NEVADA STATE CONTRACTORS BOARD ANNOUNCES EXPANDED SPANISH-LANGUAGE TESTING FOR CONTRACTOR CLASSIFICATIONS

LAS VEGAS AND RENO, NEV. – The Nevada State Contractors Board (NSCB) is pleased to announce that Professional Service Industries (PSI) now offers Spanish-language exams for 13 Nevada contractor license classifications and the Construction Management Survey exam.

Spanish testing is now available for the following classifications:

This milestone comes on the heels of the passage of the new Restricted Residential Contractor license, with applications expected to become available early next year.

David Behar, Executive Officer of the NSCB, said the initiative has been long in the making and reflects Nevada's increasingly diverse workforce. "This is an exciting time as we work to better serve our communities. Offering exams in Spanish is an important step toward opening the door for more individuals who want to enter the construction industry but previously faced language barriers. This expansion will support aspiring contractors and strengthen Nevada's workforce."

Before obtaining a Nevada State contractor's license, applicants must complete the required examination for the classification in which they are applying.
