 - Respondent is found to be in violation of Allegation No. 4 and fined \$500.
 - Fine will be dismissed once compiled financials are received, which must be received within thirty (30) days;
 - If financials are not received within thirty (30) days, License Nos. 21871 and 21872 will be immediately suspended;
 - The Respondent will have sixty (60) days to obtain a permit.

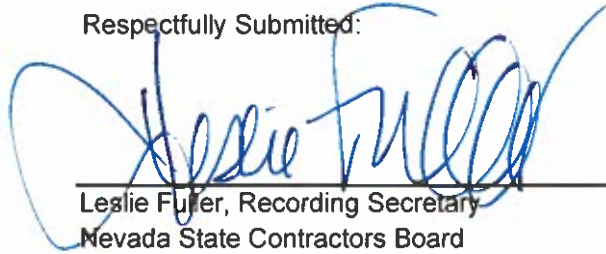
