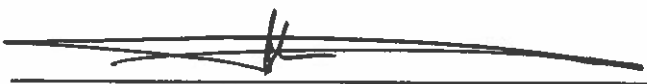
There being no further business to come before the Board, the disciplinary hearing was adjourned at **10:20 a.m.** by Administrative Law Judge Noah Allison, Esq.
